All units to be judged should be lined up by 5:30 p.m. Other units by 6:00 p.m.

Must have float completed before entering lineup area. Official entries only allowed in lineup area.

Participant drop off will be at the First Baptist Church parking lot.

All vehicle entries must use lights other than vehicle headlights.

As the appointed representative of the above named entry, I hereby release the City of Morristown or the Morristown Area Chamber of Commerce and their sponsors from liability, either direct or implied, from any accidents or damages that might occur. We understand and agree that the City of Morristown or the Morristown Area Chamber of Commerce has the right to delete any entry from the parade for any inappropriate display or behavior by any participant and, upon signing, agree to abide by all rules and conditions of participation.

- NO candy will be thrown from floats or vehicles during the parade. If you would like to pass out candy to spectators, you may have volunteers walk along the street and do so. This rule is for the safety of the crowd, to maintain a steady flow of the parade, and to limit liability in case of accident. Entries violating this rule are subject to removal from the parade and forfeiture of the right to participate in the future. The parade is videoed to help parade officials monitor the route. Please DO NOT hand out fliers or coupons or any other paper materials that could generate litter along the parade route.
- SANTA is not to be included on any entry. The only SANTA in the parade will be the Morristown Fire Department's Official Santa Claus Entry.
- NO SIRENS are to be sounded during the parade by any vehicle. You may play Christmas music at a volume that is not to drown out other floats or performers.
- To prevent gaps in the parade, units MUST NOT stop unless instructed to do so during the parade. Keep moving!
- Entry fees must be turned in before this application will be processed. The Chamber accepts cash, checks or credit cards. You may call the Chamber, 423-586-6382, and give them your credit card number; you may bring your payment to the Chamber office at 825 West First North Street, Morristown, TN 37814; or you may mail it to the Chamber at P. O. Box 9, Morristown, TN 37815
- If you have animals, you are responsible for cleaning up behind your unit. No exceptions. Horses must be bagged.
- There will be no alcoholic beverages permitted. Anyone judged by parade officials to be under the influence of drugs and/or alcohol will be asked to leave the parade area.
- The parade officials have the right to ask anyone not in compliance with the parade rules to withdraw from the parade.
- All vehicles in the Parade must be decorated with Christmas decor and lights.
- PLEASE NOTE: At least one representative for your parade entry MUST attend a safety meeting to be held on Monday, November 29<sup>th</sup> at 6:00 p.m. at First Presbyterian Church in Morristown—600 W. Main St. This is a MANDATORY meeting. Parade line-up numbers will be distributed at this meeting. If no one from your unit attends the meeting you will not be allowed to participate in the parade.

#### **Parade Route & Line Up Area**

- The Parade will begin at First Baptist Church and end at the Home Trust Bank (E. Main & Evans Ave.)
- All units entering the parade must enter the parade route from the intersection of S. Fairmont and W. Main Street and be headed EAST (toward downtown). Side streets will be blocked.
- We need all units being judged to be in place by 5:30 P.M. All other units should be in place by 6:00 p.m.
