

We kicked off the year in January with a ribbon cutting celebrating the grand opening of Greenworks' Morristown manufacturing facility and since then have had four additional ribbon cuttings, one expansion celebration for OTICS USA and our first Membership Breakfast of the year with over 100 people in attendance.

We are having great interest from new businesses joining the Chamber so far this year. We started off the year with a Board planning workshop that brought about different ideas and ways to keep strengthening the Chamber and its membership. Leadership Morristown
